This letter reports on the following minor amendments filed with the Commission on November 1, 2010, by Comcast Corporation, General Electric Company, and NBC Universal, Inc. (collectively, "Applicants") in connection with the above-captioned applications:

1. The lead FCC Form 315 application (FCC Form 315 Lead Application File No. BTCCDT-20100128AAG) was amended to: a) submit Addendum 1 to Appendix 2 to the Public Interest Statement to provide updated information; b) update Applicants' response to Section II - Question 4, Section III - Question 4, Section IV - Question 6(a), and Section IV - Question 8; and c) remove the license for TV translator station K28EY, Douglas, Arizona (FIN 41120), which was surrendered on October 19, 2010, from the list of authorizations being transferred in Section III, Question 2.

2. The non-lead FCC Form 315 applications (FCC File Nos. BTCCDT-20100128ABL, BTCCDT-20100128ABN, and BTCCDT-20100128ABR) were amended to update Applicants' response to Section II - Question 4, Section III - Question 4, Section IV - Question 6(a), and Section IV - Question 8.

3. The lead FCC Form 603 application (FCC Form 603 Lead Application File No. 0004101576) was amended to submit Addendum 1 to Appendix 2 to the Public Interest Statement and Addendum 1 to the Description of the Transaction.
