In each meeting, the Hulu representatives described Hulu’s history and ownership structure, its business model, and its current and anticipated online video programming service

offerings. We responded to questions regarding the relationship between online video programming distributors (“OVPD”), such as Hulu, and legacy linear multichannel video programming distributors with respect to factors such as revenue models and cost structure, program acquisition, advertising sales and audience measurement. We also discussed issues relating to the future access to video content by OVPDs in the context of the emergence and continued development of online distribution business models that can enhance competition in the video distribution marketplace to the benefit of consumers, content owners and advertisers.
