Dear Ms. Dortch:

This letter is being re-filed to include additional pages of the Stamped Confidential organization chart provided in the June 2, 2011 meeting.

On June 2, 2011 Dean Brenner of QUALCOMM, Incorporated (“Qualcomm”) and the undersigned, met with Joel Rabinovitz and Neil Dellar, of the Office of General Counsel, and Monica DeLong, Nese Guendelsberger, Kathy Harris, Ziad Sleem, and Paul D’Ari, all of the Wireless Telecommunications Bureau, regarding Qualcomm’s response to the May 20, 2011 General Information Request Regarding the AT&T/Qualcomm Transaction (“Request”)<sup>1</sup> in the above-referenced proceeding.

Qualcomm presented a Stamped Confidential organization chart, discussed the organization of the company, the roles of senior employees, and the roles and positions within the company of employees relevant to the Request. Qualcomm discussed a set of employees who would be deemed as custodians in connection with its production requirements under the Request, and described the position of these individuals in the company and their relation to the questions in the Request. FCC staff requested that Qualcomm provide an organization chart in a different format. Attached to this *Ex Parte*, Qualcomm has therefore attached both the organization chart provided to FCC staff in the June 2 meeting, as well as a second set of Stamped Confidential re-formatted organization chart materials to comply with the request of FCC staff.



Qualcomm also discussed its understanding of the questions, definitions, and instructions contained in the Request and methods of producing the relevant materials electronically. Finally, Qualcomm described the process it will use to search for and produce responsive documents, the time and effort needed to undertake these tasks, and that it would request an extension of time so that it can comply with the Request.<sup>2</sup>

In accordance with the Protective Order in the above-referenced proceeding, enclosed please find two redacted copies of the Stamped Confidential organization chart provided in the June 2 meeting, and two redacted copies of the Stamped Confidential re-formatted organization chart materials described above. We are also providing confidential paper copies of these materials to Kathy Harris of the Wireless Telecommunications Bureau.
