In response to a request by FCC staff, Deutsche Telekom herewith submits additional data detailing the TRXes and Erlang fractional load by sector for the T-Mobile USA network. In addition, Deutsche Telekom is also providing updates to prior data provided to the FCC to: (i) revise the list of T-Mobile USA retail locations to include locations inadvertently omitted from the June 10, 2010 filing; and (ii) revise the post-paid porting data replacing the information submitted on July 7, 2010 to correct a data error. Because all of the data is highly confidential under the Second Protective Order in this proceeding, a redacted version of the disk has not been provided.

Pursuant to the terms of the Second Protective Order, two public versions of this letter, without data disks, have been filed with the Office of the Secretary, and two copies of the Highly Confidential version of this letter, including the data disks, have been submitted to Ms. Katherine Harris of the Wireless Communications Bureau’s Mobility Division.
