Dear Ms. Dortch:

This letter and the enclosures hereto respond to the Wireless Telecommunications Bureau's December 21, 2012 letter to Verizon Wireless, which seeks written responses and supporting documentation for two requests for information.¹ Verizon Wireless has made a good faith effort to provide the information and documents requested. Pursuant to a discussion with Bureau Staff on January 11, 2013, it is providing information and documents as to both requests, and will provide additional documents that it determines are responsive once it has completed further research.

This response includes highly confidential information that is some of Verizon Wireless' most sensitive business information, is not available from publicly available sources, has been kept strictly confidential by Verizon Wireless, and is subject to protection under FOIA and the Commission's implementing rules. Moreover, the Information Request states that Verizon Wireless' response "will be treated as highly confidential" pursuant to the Second Protective Order released in this proceeding.² Accordingly, Verizon Wireless is submitting this information


