## MEDIA BUREAU IS PREPARED TO GRANT CERTAIN AUCTION NO. 37 BROADCAST CONSTRUCTION PERMIT APPLICATIONS

Final Payments Due by October 6, 2005

#### **Auction No. 37**

#### Report No. AUC-04-37-AA

On November 23, 2004, the Federal Communications Commission completed the auction of 288 FM broadcast construction permits ("Auction No. 37"). By this Public Notice, the Media Bureau, under delegated authority, announces that it is prepared to grant the construction permit applications listed in **Attachment A** of this Public Notice following the full and timely payment of the remaining balance of the applicant's winning bid. Therefore, in accordance with the procedures adopted in the *Broadcast First Report and Order*, a lump sum final payment from the Auction No. 37 winning bidders listed in Attachment A must be received by the Commission within **ten business days** of the date of this Public Notice, *i.e.*, by **October 6, 2005**.

The Part 1 competitive bidding rules provide for an additional ten-business-day grace period for applicants that fail to submit final payments by the October 6, 2005 deadline.<sup>4</sup> Pursuant to Section 1.2109(a) of the Commission's rules, a winning bidder that fails to pay the balance of its winning bid(s) in a lump sum by the deadline specified by the Commission may make a late payment within ten business days after the payment deadline, *i.e.*, by **October 21, 2005**, provided that it also pays a late fee equal to

five percent of the amount due.<sup>5</sup> If a winning bidder listed in Attachment A fails to pay the balance of its winning bid(s) by the late payment deadline of October 21, 2005, it will be in default and subject to the default payment procedures specified in the Commission rules.<sup>6</sup>

By public notice, the Media Bureau will announce the grant of the construction permits for which the Commission has received timely final payments of the winning bid amounts. Facility authorizations will be issued shortly thereafter.

#### **PAYMENT INSTRUCTIONS**

All payments must be made in U.S. currency in the form of a wire transfer. *See* 47 C.F.R. § 1.2107(b). No personal checks, cashier's checks or other forms of payment will be accepted.

Timely wire transfer payments must be received by Mellon Bank by 6:00 p.m. ET, October 6, 2005. Late payments, which must include the five percent late fee, must be received by Mellon Bank by 6:00 p.m. ET, October 21, 2005. Applicants must allow sufficient time for the wire transfer to be initiated and for the transmission to be completed prior to the deadline.
