NATIONAL EXCHANGE CARRIER ASSOCIATION, INC.'S PROPOSED 2012 MODIFICATION OF AVERAGE SCHEDULE FORMULAS

PLEADING CYCLE ESTABLISHED **WC Docket No. 11-204**

Comments Due: February 14, 2012
Reply Comments Due: February 24, 2012

On December 22, 2011, the National Exchange Carrier Association, Inc. (NECA) filed with the Commission its proposed modification of average schedule formulas for interstate settlements, pursuant to section 69.606 of the Commission's rules.¹ NECA proposes to revise the formulas for average schedule interstate settlement disbursements in connection with the provision of interstate access services for the period beginning July 1, 2012, through June 30, 2013.

Modifications to the average schedule formulas are based on a statistical sampling of the costs and demand of comparable cost companies. NECA indicates that the modifications include its proposal to divide the special access settlement formula into two parts, one for DSL costs, and the other for all other special access costs.² The proposed DSL formula is based on DSL line counts and DSL penetration.³ The proposed formula for other special access costs continues as a formula based on special access revenues and a retention ratio calculation.⁴ Overall, NECA estimates that the proposed formula changes would decrease settlement rates by approximately 5.0 percent, given constant demand.⁵ The effects of these formula changes on individual average schedule companies will vary depending on each company's size and demand characteristics. Companies who provide DSL through NECA's tariff (197

study areas) would experience an average increase of 3.2 percent in total settlements.⁶ In total, NECA estimates that 221 study areas will experience settlement increases, while 171 will experience decreases.⁷

Interested parties may file comments on NECA's proposed modifications on or before **February 14, 2012** and reply comments on or before **February 24, 2012**. Filings in this proceeding should be captioned "National Exchange Carrier Association, Inc.'s Proposed 2012 Modification of Average Schedule Formulas" and filed in **WC Docket No. 11-204**.

This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.⁸ Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentations and not merely a listing of the subjects discussed.
