## **Comment Deadlines Set for *Notice of Proposed Rulemaking* Relating to Broadcast Licensee-Conducted Contests**

**MB Docket No. 14-226**

**Comment Deadline: February 17, 2015**  
**Reply Comment Deadline: March 19, 2015**

On November 21, 2014, the Commission released a *Notice of Proposed Rulemaking* (“*NPRM*”) in MB Docket No. 14-226 proposing to amend Section 73.1216 of its rules governing broadcast licensee-conducted contests.<sup>1</sup> The Commission set deadlines for filing comments and reply comments at 60 and 90 days, respectively, after publication of the *NPRM* in the Federal Register. A summary of the *NPRM* was published in the Federal Register on December 19, 2014.<sup>2</sup> Thus, comments must be submitted no later than February 17, 2015. Reply comments must be submitted no later than March 19, 2015. Commenters must follow the filing instructions provided in paragraphs 18-19 of the *NPRM*.<sup>3</sup> The *NPRM* is also available on the Commission’s website.<sup>4</sup>
