## NOTICE OF EFFECTIVE DATE OF HEARING AID COMPATIBILITY RULES

CG Docket No. 13-46, WT Docket Nos. 07-250 and 10-254

On October 24, 2017, the Federal Communications Commission (Commission or FCC) amended the hearing aid compatibility (HAC) rules governing wireline and wireless handsets.<sup>1</sup> Among other things, the Commission approved a new wireline HAC volume control standard, adopted a requirement for volume control in wireless handsets, and eliminated an obsolete wireless handset standard.<sup>2</sup> The effective date for these rules is March 30, 2018,<sup>3</sup> which is thirty days after the date of publication of the *HAC Order* in the *Federal Register*.<sup>4</sup>
