## PLEADING CYCLE ESTABLISHED FOR COMMENTS ON SECURUS TECHNOLOGIES, LLC'S REQUEST FOR WAIVER OF USF CONTRIBUTIONS OBLIGATIONS FOR ICS PROVIDERS

Comments or Oppositions Due: April 10, 2020

Reply Comments Due: April 17, 2020

The Wireline Competition Bureau seeks comment on a request for waiver filed by Securus Technologies, LLC (Securus). Securus requests an immediate waiver from the application of Universal Service Fund (USF) contribution obligations as set forth in Section 54.706 of the Commission's rules with respect to inmate calling services (ICS) providers on an interim basis. Securus also requests that the Commission expeditiously grant the petition for forbearance filed by Network Communications International Corporation in order to extend relief from USF contribution obligations to ICS providers on a permanent basis.

Pursuant to sections 1.415 and 1.419 of the Commission's rules, 47 CFR §§ 1.415, 1.419, interested parties may file comments or oppositions to the Securus Waiver Request on or before April 10, 2020 and reply comments on or before April 17, 2020. Comments and oppositions should reference WC Docket No. 19-232 and may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.<sup>4</sup>

**Ex Parte Rules**. The proceeding this Notice initiates shall be treated as "permit-but-disclose" proceeding in accordance with the Commission's ex parte rules.<sup>6</sup> Persons making ex parte presentations must file a copy of any written presentation or a memorandum summarizing any oral presentation within two business days after the presentation (unless a different deadline applicable to the Sunshine period applies). Persons making oral ex parte presentations are reminded that memoranda summarizing the presentation must (1) list all persons attending or otherwise participating in the meeting at which the ex parte presentation was made, and (2) summarize all data presented and arguments made during the presentation. If the presentation consisted in whole or in part of the presentation of data or arguments already reflected in the presenter's written comments, memoranda or other filings in the proceeding, the presenter may provide citations, to such data or arguments in his or her prior comments, memoranda, or other filings (specifying the relevant page and/or paragraph numbers where such data or arguments can be found) in lieu or summarizing them in the memorandum. Documents shown or given to Commission staff during ex parte meetings are deemed to be written in ex parte presentations and must be filed consistent with rule 1.1206(b). In proceedings governed by rule 1.49(f) or for which the Commission has made available a method of electronic filing, written ex parte presentations and memoranda summarizing oral ex parte presentations, and all attachments thereto, must be filed through the electronic comment filing system available for that proceeding, and must be filed in their native format (e.g., .doc, .xml, .ppt, searchable .pdf). Participants in this proceeding should familiarize themselves with the Commission's ex parte rules.
