**UNOPPOSED MOTION TO EXTEND DEADLINES FOR RESPONSE AND REPLY**

Respondent NV Energy, Inc. ("NV Energy"), pursuant to 47 C.F.R. §1.46, moves for a seven (7) day extension of the response and reply deadlines established by the December 29, 2014 Notice of Complaint and 47 C.F.R. § 1.1407.

In support of this motion, NV Energy says the following:

1. Cox Communications Las Vegas, Inc. ("CCI-LV") filed its pole attachment complaint on December 18, 2014. The Bureau's December 29, 2014 Notice of Complaint established the following deadlines:

- January 23, 2015: NV Energy's deadline to respond to CCI-LV's complaint;
- February 13, 2015: CCI-LV's deadline to reply.

2. NV Energy respectfully requests that those deadlines each be extended by seven (7) days to **January 30, 2015** and **February 20, 2015**, respectively.

3. The thirty (30) day period for NV Energy's response to the complaint includes the New Year holiday.

4. Preparation of NV Energy's response to the complaint requires the cooperation of, and declarations from, various NV Energy personnel. Some of these personnel were unavailable during the intervening holiday week of December 29, 2014.

5. CCI-LV will not be prejudiced by the short extension NV Energy seeks. Further, this motion seeks to extend CCI-LV's reply deadline by a corresponding seven (7) days.

6. Undersigned counsel has conferred with counsel for CCI-LV, and CCI-LV consents to the requested extension of deadlines.

For the reasons stated herein, NV Energy respectfully requests that the Commission extend the response deadline to **January 30, 2015** and extend the reply deadline to **February 20, 2015**.
