Data Formatting

All data should be submitted in a .csv (comma-delimited) format. The sheets in the workbook provide a template for how the tables should be designed.

The required format for the entries in each column/field is indicated in the instructions for each sheet. Column entries in **bold red** indicate that the Company should enter only one of the possible entries listed for that column. No other entries should be entered.

Data for all of the tables should be submitted on a periodic basis as specified in the instructions in individual tables.

"Video Programming" Table (for set of specified national networks that are provided to all subscribers)

For each month beginning June 2012 and extending through August 2015, please provide data by network as requested in the table below. Please include all networks that at least 90 percent of expanded basic video subscribers, for both Charter and TWC, receive.

Attachment E: Template and Instructions for "Video Programming" Table

Due to the sensitivity of programming payment information, this table will need to be produced by a third party that can view the programming contracts. An example follows.

The table requests data on networks that at least 90 percent of the subscribers to the Expanded Basic video tier, on both Charter and TWC, receive. Suppose that there are three such networks. Call these networks "X," "Y," and "Z."

The third party would have access to the contracted and actual payments that both companies made for these networks. Suppose that the per-subscriber rates for June 2012 are as shown below.

Note that the last row in the sample table above, which has the entry "-1" in the network_id column, captures the ratios of simple (i.e., unweighted) sums, over all three requested networks, of the two companies' corresponding rates.
