Licensees that did meet their construction requirement have 30 days from the date of this Public Notice to file a petition for reconsideration showing that they have timely met the construction deadline.

In filing a petition for reconsideration, the licensee must include the actual date when construction was completed. Petitions for reconsideration may be filed electronically through ULS or by paper through the Office of the Secretary.
