

Re: Letter of Concurrence & Support for Tecore Government Service Pilot in Baltimore, MD - File No. 0735-EX-ST-2012

Dear Sir or Madam:

Pursuant to Part 5 of the rules of the Federal Communications Commission ("Commission"), 47 C.F.R. Part 5, the Cellco Partnership d/b/a Verizon Wireless, a Delaware general partnership ("Cellco"); Verizon Wireless Personal Communications LP, a Delaware limited partnership ("VWPC"); Verizon Wireless Telecom Inc., a Delaware corporation ("VWT"), hereby submits this letter of concurrence with the associated application File No. 0735-EX-ST-2012 for an experimental Special Temporary Authorization ("STA") in Baltimore, MD at the MTC facility located at 954 Forest St., filed by Tecore Government Services, LLC. Tecore seeks to demonstrate the feasibility of their proprietary technology, in a "real-world" environment during a period from grant of this experimental STA by the Commission until January 1, 2013.

Tecore requests to use the above noted frequencies for its demonstrations. Tecore is working cooperatively with Verizon Wireless and has agreed to coordinate the demonstrations of its technology with Verizon Wireless and will avoid harmful interference while conducting the demonstrations. In addition, Tecore has agreed to immediately cease operations should any interference issues arise during the demonstrations.

Verizon Wireless desires to support Tecore testing of its technology and, therefore, agrees to permit Tecore to use Spectrum for a period up to January 1, 2013 after the grant of the associated application. In authorizing Tecore to use Verizon Wireless' licensed spectrum in this manner, Verizon Wireless accepts responsibility for any failure of an actual subscriber communication which may occur, despite preventive measures, during the course of Tecore operations under the requested experimental STA. Accordingly, Verizon Wireless supports the grant of the associated Tecore application for an experimental STA to operate its Correctional Cellular Communications Call Control System for a period up to January 1, 2013 after the grant of the associated application. Verizon Wireless has received a copy of the instant application.
