This Special Temporary Authorization is granted upon the express condition that it may be terminated by the Commission at any time without advance notice or hearing if in its discretion the need for such action arises. Special Conditions:

- (3) Prior to equipment authorization or a determination of compliance, the device must be accompanied by a conspicuous notice worded as follows: "This device has not been authorized as required by the rules of the Federal Communications Commission. This device is not, and may not be, offered for sale or lease, or sold or leased, until authorization is obtained."
- (4) Maintain operation separation from the grandfathered earth stations as defined in Part 90, sub-part Z, or coordinate an agreement with the grandfathered earth station licensees prior to operation in 3550-3700 MHz band.
- (5) Consult the ULS database to ensure that the operation will not cause harmful interference to any existing registered stations in the 3650-3700 MHz, and notify the registered users in the area.
