NAME Space Exploration Technologies Corp. (SpaceX)

This Special Temporary Authorization is granted upon the express condition that it may be terminated by the Commission at any time without advance notice or hearing if in its discretion the need for such action arises. Nothing contained herein shall be construed as a finding by the Commission that the authority herein granted is or will be in the public interest beyond the express terms hereof.

This Special Temporary Authorization shall not vest in the grantee any right to operate the station nor any right in the use of the frequencies designated in the authorization beyond the term hereof, nor in any other manner than authorized herein. Neither the authorization nor the right granted hereunder shall be assigned or otherwise transferred in violation of the Communications Act of 1934. This authorization is subject to the right of use of control the Government of the United States conferred by Section 706 of the Communications Act of 1934.

Special Temporary Authority is hereby granted to operate the apparatus described below:

Special Conditions:

- (1) Operation is subject to prior coordination with the local Society of Broadcast Engineers, Inc. (SBE) frequency coordinator. Consult the list at https://www.sbe.org/sections/freq_local.php to find the appropriate coordinator.
- (2) All operations shall be limited to the TC uplink from an onshore station at CCAFS that covers the experimental first-stage recovery operation, following a Falcon Heavy launch from Cape Canaveral. This includes pre-launch check-out operations at CCAFS as pre-coordinated with the launch Range. This STA will expire as soon as the first-stage recovery operation has been completed or 27 November 2019, whichever occurs first.
- (3) Prior to transmitting at CCAFS, Florida, SpaceX shall coordinate and schedule their operations with Range Scheduling, COMM: (321- 853-5941, email: 1ropschd@us.af.mil and provide a copy of FCC license to the 45th Space Wing Spectrum Management Office, (321)-853-8408, email: 45sw.erfmo@us.af.mil
- (4) All SpaceX operations granted on an experimental basis shall be on an unprotected, non-interference basis to authorized federal stations.
