- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) Consult the ULS database to ensure that the operation will not cause harmful interference to any existing registered stations in the 3650-3700 MHz band, and notify the registered users in the proposed geographic areas prior to operation in this band.
- (4) Maintain operation separation from the grandfathered earth stations as defined in Part 90, Sub-part Z, or coordinate an agreement with the grandfathered earth station licensees prior to operation in 3650-3700 MHz band.
- (5) CCO Fiberlink, LLC will be responsible for ensuring that the devices are used in authorized locations and in a manner authorized.
- (6) All of the experimental devices will be under control of CCO Fiberlink, LLC and they will be retrieved by CCO Fiberlink, LLC from the participants upon completion of the experiment.
- (7) Further requests for extension of the authority granted herein must be filed on Form 442, "Application for New or Modified Radio Station Authorization under Part 5 of FCC Rules Experimental Radio Service." Future STA requests to extend this authorization will not be considered.
