Ms. Woody:

Good afternoon.

The FCC has requested that Leidos obtain NRQZ coordination for a newly-filed experimental application for airborne operations at and around Bridgewater, VA.

The FCC has requested NRQZ coordination by October 27, 2021 for this filing – which is pending under File No. 0814-EX-CN-2021.

As you can see in the attached PDF (and in the screenshot below), the application seeks authority only for mobile airborne operations:

Accordingly, Leidos understands that because the operations are mobile-only and there are no fixed terrestrial facilities associated with these operations, coordination within the NRQZ is not required by Federal Law 47CFR1.924 for Quiet Zones or the US Department of Commerce NTIA Frequency Management manual Section 8.3.9.

If you agree, and if you are able to provide confirmation of same, we will advise the FCC and this matter can be expeditiously resolved.
