Answer 4: Recent auctions for mid-band 5G spectrum resulted in billions of dollars from competing telecom providers, testing will occur in these bands but will not result in service competition.

(5) Explanation of how disclosure of the information could result in substantial competitive harm;

Answer 5: MIT LL operates not-for-profit federal research and development center under prime contract to U. S. Air Force and, as such, is subject to Defense Federal Acquisition Regulation Supplement regulations to protect confidential data defined as information which requires safeguarding or dissemination controls pursuant to and consistent with applicable law, regulations, and government-wide policies but is not classified under Executive Order 13526 or the Atomic Energy Act, as amended. Failure to protect information could result in lack of future access to said information (among other penalties).

(6) Identification of any measures taken by the submitting party to prevent unauthorized disclosure;
