MIDLANTAFC does not object to the use of the lower L-band channel usage (Frequencies: (MHz) 1439.0/1447.0/1455.0/1463.0/1471.0/1479.0/1487.0/1495.0/1503.0/1511.0/1519.0/2364.0/2372.0 and 2380.0 under AFTRCC ICN 1163-22/9312 (BSI STA/Nascar/SuperCross Events-Hampton, GA) with the following limitations and restrictions:

- 1) Non-interference basis to all Flight Test telemetry missions and no protection afforded to Broadcast Sports Intl operations.
- 2) Unprotected NIB operations are under a MO station class.
- 3) STOP BUZZER POC provided with cell and land line contact information that can cease any and all Broadcast Sports Intl emissions if EMI is detected.
