MIDLANTAFC does not object to the use of the lower L-band and upper S-band channel usage (Frequencies: (MHz) 1435.0 - 1525.0 and 2360.0 – 2390.0 under AFTRCC ICN 1248-22/9349 (BSI STA/NASCAR Event-Dover, DE) with the following limitations and restrictions:

- 1) Non-interference basis to all Flight Test telemetry missions and no protection afforded to Broadcast Sports Intl operations.
- 2) Unprotected NIB operations are under an MO station class.

3) STOP BUZZER POC provided with cell and land line contact information that can cease any and all Broadcast Sports Intl emissions if EMI is detected.
