Regarding transmissions within the Quiet Zone and getting an STA from the FCC, here is a statement from us to you, that you can forward to the FCC. If this statement does not meet the FCC's needs for granting the STA, please let us know, and we'll communicate directly with your contact(s) there, to get the STA cleared as far as the Quiet Zone is concerned.

"The NTIA/ITS Boulder Laboratory is engaged in a technical study with Dish Wireless, which will require the temporary operation of some Dish transmitters within the Table Mountain Radio Quiet Zone north of Boulder. Regarding any potential issues with the operation of these radios within the Quiet Zone, ITS has/will coordinate(d) the operation of these radio transmitters locally with the Table Mountain User's Group. Insofar as there may be any concerns with the Quiet Zone's field strength protection limits, it is requested that the FCC analyze the STA request as regards maintaining non-interference to local systems in the Longmont, Colorado area (outside the Quiet Zone), but without being concerned about protecting the Quiet Zone itself. Please contact Frank Sanders of NTIA/ITS at the phone number below, if further coordination or issues need to be addressed concerning protection of the Table Mountain Radio Quiet Zone *vis-à-vis* this STA request."
