Below is an email trail where Northrop Grumman Corp (NGC) had requested MAG coordination for UHF frequencies. They have been told about 3 frequency assignments that are in place in support of MQ-8C Fire Scout UAS. I've attached the 3 RFAs.

NGC has permission to use these frequency assignments for a Fire Scout platform that is not going to be delivered to the Navy, but used by NGC for R&D. The program manager for MQ-8C Fire Scout, PMA-266 Capt Monagle, is aware of this effort and supports it.

I will submit modifications to these permanent assignments, in order to update the STOP BUZZER. Nothing else has changed.
