MIDLANTAFC does not object to the use of the lower L-band channel usage (Frequencies: (MHz) 1435.0 - 1525.0 under AFTRCC ICN 1262-23/APP-2023-1117 (BSI STA/Cognizant Founders Cup-Clifton, NJ) with the following limitations and restrictions:

- 1) Non-interference basis to all Flight Test telemetry missions and no protection afforded to Broadcast Sports Intl operations.
- 2) Unprotected NIB operations are under an MO station class.
- 3) STOP BUZZER POC provided with cell and landline contact information that can cease any and, all Broadcast Sports Intl emissions if EMI is detected.
