Assignment of Orbit and Frequency Usage Rights for the Satellite CRYPTO3

Dear Mr. Winetraub,

Please find hereby attached the Assignment of Orbit and Frequency Usage Rights for the satellite CRYPTO3 and the associated unofficial translation.

Please note, in accordance with the "Procedures for the advance publication, coordination and notification of satellite systems in the name of Germany and for the assignment of orbit and frequency usage rights – VVSatSys", the orbit and frequency usage rights are only transferred to the extent that rights can be derived from the result of international and national coordination. The coordination results are part of the transfer of usage rights. We may have to restrict or revoke the usage rights based on the coordination results.

The assignment of orbit- and frequency usage rights is earmarked and granted under certain conditions and requirements, which you can find in detail in the assignment and, if applicable, in the associated assignment annexes.

Taking into account these requirements, we can only temporarily transfer the usage rights regarding the incomplete coordination of the satellite system. Until coordination is complete, the rights of use may only be exercised on a "**non interference basis**" (NIB).

If there is a disturbance, the transmissions must be stopped immediately and without delay. In addition, no right to protection against interference with one's own transmission can be claimed.

Without notification, the assignment of the orbit and frequency usage rights will be revoked after the 7-year period in accordance with the ITU regulations. The transmissions must then be stopped immediately and without delay. They may also no longer be exercised on a non-interference (NIB) basis.

With the transfer of the orbit and frequency usage rights, I assigned the usage rights number 009-2023/BNetzA (223).

I ask you to give this number in future in every correspondence or in the case of telephone inquiries.
