MIDLANTAFC does not object to the lower L-band and upper S band usage (Frequencies: (MHz) 1476.0 - 1499.0 under AFTRCC ICN 1136-24/APP-2024-1043 (CPCOMMS STA/College Golf-Hilton Head, SC) with the following limitations and restrictions:

- 1) Non-interference basis to all Flight Test telemetry missions and no protection afforded to CP Communications operations.
- 2) Unprotected NIB operations are under an MO station class.

3) STOP BUZZER POC provided with cell and landline contact information that can cease any and, all Aerial Video Systems emissions if EMI is detected.
