MIDLANTAFC does not object to the use of the lower L-band (Frequencies: (MHz) 1435.0 - 1525.0 under AFTRCC ICN 1308-24/APP-2024-1359 (BSI STA/LPGA Event-Galloway, NJ) with the following limitations and restrictions:

- 1) Non-interference basis to all Flight Test telemetry missions and no protection afforded to Broadcast Sports Intl operations.

2) Unprotected NIB operations are under an MO station class ONLY.

3) STOP BUZZER POC provided with cell and landline contact information that can cease any and, all Broadcast Sports Intl emissions if EMI is detected.
