Hi Joe,

Hope all is well! I'm reaching out because one of my clients (Chaos Industries, Inc.) has experimental license applications pending before the FCC seeking authorization to operate in the 223-235 MHz band in and around Hermosa Beach, CA and Hawthorne, CA. The FCC has asked that we coordinate with Fox station KCOP-TV, Los Angeles, CA and obtain consent from the station to enable it to continue processing the applications. I have attached the pending license applications that include the technical parameters.

Chaos has operated in the 220-225 MHz band from the Hermosa Beach site for the past 6 months under experimental special temporary authority with no reported interference. While Chaos does not anticipate causing interference to KCOP-TV, it will immediately cease transmissions upon becoming aware of causing harmful interference to KCOP-TV's operations as required under 47 C.F.R. § 5.84.

The following Chaos personnel will be available by mobile phone and will act as the "stop buzzer" if any issues arise during testing: Primary: Bo Marr – 310-487-5016; Secondary: Daniel Thompson – 405-388-0692.

Could you please confirm KCOP's consent by Friday, November 1? Or please let me know if you need more time, or if I should connect with someone else at Fox on this issue. Happy to chat by phone if that would be helpful.
