To operate in the 2200-2290MHz and 4400-4940MHz Telemetry Bands in Morris County, New Jersey.

Morris County Department of Law and Public Safety hereby requests Special Temporary Authorization (STA) to operate within the 2200-2290MHz and 4400-4940MHz telemetry bands pursuant to Section 21.25 of the Commission's Rules. Morris County Department of Law and Public Safety requests that the Commission grant it temporary authority to operate on the frequencies centered at 2210MHz, 2280MHz, 4510MHz and 4650MHz with a 20MHz bandwidth from December 15, 2024, through May 15, 2025, with intermittent usage. If the 2210MHz, 2280MHz 4510MHz or the 4650MHz frequency range is unavailable, any 20MHz channel within the bands 2200-2290MHz and the 4400-4940Mhz will suffice. As explained below, Morris County Department of Law and Public Safety is filing an STA request to demonstrate, experiment and train those who serve across Public Safety, Government, Defense, Security and Enterprise in the utilization and application of wireless technology in a MIMO/MANET emission scheme during emergency operations. Morris County Department of Law and Public Safety submits that there are extraordinary circumstances warranting a grant of the STA request.

Morris County Department of Law and Public Safety is demonstrating, experimenting and training those who serve across Public Safety, Government, Defense, Security and Enterprise in the utilization and application of wireless MIMO/MANET technology in their field during emergency operations. Due to the extreme frequency congestion in the Morris County area, coupled with the added congestion from traditional Television and News coverage of area events, Morris County Department of Law and Public Safety requests the use of these channels.

Morris County Department of Law and Public Safety certifies that the operation of the requested channels for the purposes specified herein will not cause interference to any established stations.

Grant of the instant request for STA for the 2.2GHz band and the 4.5GHz bands would serve the public interest by enabling Morris County Department of Law and Public Safety to provide a platform to train, demonstrate and experiment wirelessly with MIMO/MANET technologies for individuals who support Public Safety, Government, Defense, Security and Enterprise during emergency operations.
