SECTION 9 - CONTRACT TARIFFS

9. Contract Tariffs

This section contains terms and conditions and rates and charges for contract tariffs provided by Company. Individual contract tariffs are filed beginning at 9.2 following.

9.1 General

Contract tariffs apply in those Metropolitan Statistical Areas (MSAs) where Company has received Phase I Pricing Flexibility relief for Fast Packet Services.

Each contract tariff includes a serving area that is comprised of one or more MSAs within the operating territories set forth in Section 7 preceding of one or more of the Verizon Telephone Companies participating in this tariff. The remaining Verizon Operating Telephone Companies participate in Tariff F.C.C. No. 1, No. 11, and/or No. 14 as shown below. These tariffs also specify the operating territories of each company.

Unless otherwise specified in the individual contract tariff option, when the serving area for a contract tariff encompasses more than one Verizon Operating Company, that contract aggregates services, rates and charges, incentives and other contract-specific terms and conditions for MSAs within all of the Verizon Operating Telephone Companies participating in that contract.
