2.4.8 Optional Payment Plans (Cont'd)

(H) BellSouth Transport Advantage Plan (TAP)

Effective November 15, 2007, the BellSouth Transport Advantage Plan (TAP) will no longer be available for new customer subscriptions. (N)
Customers with an existing TAP may keep the TAP under the terms and (N)
conditions specified herein until the term of the TAP expires. (N)

- (1) The BellSouth Transport Advantage Plan is a volume and term plan that (T)
allows customers to receive rewards in the form of credits applied to
their bill in exchange for having maintained a specified level of
Special Access and Switched Access dedicated transport services
recurring billing for a specified period of time. To qualify for the
BellSouth TAP, a customer must have \$3M or greater of annual
recurring revenue associated with Qualifying Access Services.
Qualifying Access Services are described in 2.4.8(H)(7) following.
The credits provided under this plan will be applied to Eligible
Access Services recurring billing. Eligible Access Services are as
defined in 2.4.8(H)(6) following.
- (2) Customers that qualify for BellSouth TAP may subscribe to a single
term only. The term of a BellSouth TAP is three (3) years. The
BellSouth TAP effective service date will be negotiated by the
Telephone Company and the customer.
- (3) When a customer subscribes to the BellSouth TAP it must identify to
the Telephone Company all Access Customer Name Abbreviations (ACNAs)
owned by a company to be included in the BellSouth TAP.
- (4) Customers that subscribe to BellSouth TAP may not also subscribe to
the BellSouth Transport Savings Plan (TSP) or BellSouth Premium
Service Incentive Plan (PSIP). Customers that subscribe to the
BellSouth TSP that desire to establish a BellSouth TAP must terminate
their BellSouth TSP as of the effective date of their subscription to
BellSouth TAP. Such termination of a customer's BellSouth TSP shall
be without termination liability. All BellSouth TSP shortfall
charges billed at the time of subscription to BellSouth TAP must be
satisfied prior to the effective date of the BellSouth TAP. Credits
will begin one month following the next billing period of the
effective BellSouth TAP agreement date.
- (5) For customers who qualify and desire to subscribe to a BellSouth TAP,
the customer must establish a BellSouth TAP Commitment Level. The
BellSouth TAP Commitment Level may be any one of the Volume Bands as
set forth in 2.4.8(H)(9) following.
