This filing is made to establish regulations for the provision of switched dedicated, and special access services in the Cincinnati, OH-KY-IN Metropolitan service Area (MSA) and the Hamilton-Middletown, Ohio MSA where CBT has been granted Phase I and Phase II pricing flexibility in accordance with subpart H of the Commission's Part 69 Rules¹
