With this filing, Ameritech is proposing to increase the following rates: (1) Residence and Operator Services Usage Rates, (2) Operator Assistance Service Charges, (3) the Directory Assistance Charge and (4) the Payphone Use Charge, as shown in Section 3 of Tariff F.C.C. No. 4, Interstate IntraLATA Message Telecommunications Services. The proposed rate changes do not affect price cap indices. Customers were notified of these rate increases via bill page messages, during the billing periods of March 21, 2008 through April 21, 2008, March 23, 2008 through April 22, 2008 and March 27, 2008 through April 24, 2008.

In accordance with Section 61.14, this transmittal letter and associated attachments are being filed electronically today via the Federal Communications Commission's Electronic Tariff Filing System (ETFS) in compliance with the electronic filing procedures.
