Dear Secretary:

The accompanying Tariff Review Plan and associated supporting documentation is sent to you for filing in compliance with the Communications Act of 1934, as amended. This filing is being made on behalf of Frontier Telephone of Rochester, Inc. ("FTR") and its affiliated exchange carriers ("Frontier Tier 2's") that concur in FTR's tariff F.C.C. No. 1.

In accordance with the Commission's requirements as specified in the Commission's *Order*, July 2008 Annual Access Charge Tariff Filings, released March 28, 2008, DA 08-758 ("*2008 Filing Order*"); and *Tariff Review Plans*, Material to be Filed in Support of 2008 Annual Tariff Filings, DA 08-759, released March 28, 2008 ("*2008 TRP Order*"), FTR is submitting revisions to its Price Cap Indices to be effective June 30, 2008. The PCI revisions are as complete and accurate as possible for this early filing date. Subsequent Commission action (e.g., adoption of a revised TRS Contribution Factor) may result in revisions for the June, 2008 Annual Tariff Filings that are not quantifiable at this time.

The *2008 TRP Order*, at ¶20, directs ILECs "to provide a list of services not in price caps and the tariff section associated with that service. . . . ILECs should clearly state in their cover letters where this information can be found in their TRP." FTR has provided such a list in compliance with this paragraph as Exhibits 4-1 and 4-2 in the accompanying support material.
