RE: 2008 Price Cap Revisions Errata Filing

On May 1, 2008, BellSouth Telecommunications, Inc. (BellSouth) submitted a letter filing to provide revised Price Cap Indices (PCIs) for each basket of services in preparation for the 2008 Annual Tariff Filing to be submitted on June 16, 2008. This errata letter filing revises the May 1 filing, and it includes the following modification.

- Revised exogenous amounts and revenue levels to reflect the Pricing Flexibility Petition Order DA 08-1171, released May 16, 2008

This letter is filed in compliance with Order DA 08-758, In the Matter of Material to be Filed in Support of 2008 Annual Access Tariff Filings, (2008 TRP Order), released March 28, 2008, and Order DA 08-759, In the Matter of July 2008 Annual Access Charge Tariff Filings, released March 28, 2008.
