This filing proposes the rates and charges applicable to Switched Access, Special Access and Miscellaneous Service and is filed in compliance with F.C.C. Rules and Regulations, Part 61.39 and is in compliance with the ROR Access Reform Order, CC Docket 00-256.

This filing reflects the removal of ADSL (Asymmetric Digital Subscriber Line) Access Service from Benton Ridge Telephone Company's Section 17.4, as this company has opted to offer wireline broadband Internet access transmission service on a detariffed, common carrier basis effective July 1, 2008 consistent with the Commission's requirements in Docket No. 02-33.<sup>1</sup>
