21.4.2 Service Description (Cont'd)

(4) Transfer of Service

When a change in billing data (e.g., name, address, contract name, or telephone number) is requested in association with a change in the customer's record, transfer of service charges, as set forth in 21.4.10(D) following will apply. Charges are applied on a Billing Account Number (BAN).
