The enclosed tariffs, issued by the Verizon Telephone Companies (Verizon) and bearing Tariff FCC Nos. 1 and 11, Access Service, are being sent to you for filing in compliance with the requirements of the Communications Act of 1934, as amended. This material, filed on 15 days' notice and scheduled to become effective August 12, 2008, consists of tariff pages as indicated on the following check sheets:

Verizon is submitting revisions to tariff pages to introduce an installation nonrecurring charge for High Definition Digital Video Transport Service (Hi-Def DVTS) purchased on a month-to-month basis. The minimum service period for Hi-Def DVTS purchased on a month-to-month basis will be reduced from three (3) months to one (1) month. Also with this filing, the month-to-month channel termination monthly rate is being reduced.

Also with this filing, Verizon is introducing Pricing Flexibility rates for those N-MSA Hi-Def DVTS and advanced video switching rate elements introduced in Tariff FCC No. 1 on May 29, 2008 under Transmittal No. 918.

Supporting material as specified under Section 61.49 of the Commission's Rules is provided with this filing. In addition, a document with a detailed explanation of the filing is being provided as an attachment hereto.

This transmittal letter and associated attachments are being filed electronically today via the Federal Communications Commission's Electronic Tariff Filing System (ETFS).
