With this filing, BellSouth is proposing to provide clarification to existing regulations as they relate to the Federal Universal Service Fund (FUSF) Surcharge and the customer's exemption from this Surcharge. Customers are required to certify their FUSF exemption status annually. New language regarding these requirements is being added to the tariff. In addition, references and acronyms for FUSF are being corrected throughout the tariff. These changes will have no impact to existing customers.
