Protected Cincinnati Bell Ethernet Service gives customers protection from equipment and network failure by designating a circuit with primary and secondary fiber pairs and network facing equipment redundancy. Each fiber pair terminates into its own individual port both at the central office switch and at the Company owned customer-premises equipment, giving each fiber pair its own connection to the Cincinnati Bell Ethernet Service network. In the event of a primary connection failure, traffic will automatically reroute to the secondary connection. The customer-owned equipment plugs directly into the Cincinnati Bell Ethernet Service circuit by a standard, single Ethernet port. The design does not include geographic fiber route diversity, location, or dual customer hand-offs. (T)
