In this filing Qwest is filing tariff material in Section 8, Advanced Communications Networks, to revise the Frame Relay Service (FRS) Renewal Discount Plan for Fixed Period Rate Plans. This change is being made to limit the eligibility for this offer to 3 months after the expiration of the Pricing Plan.

As part of this filing Qwest is also deleting duplicative and obsolete tariff material contained in Sections 7, 8 and 11. Qwest is deleting Channel Interface and Network Channel Codes that are addressed specifically by product in technical publications referenced in the tariff. Obsolete promotions in Section 7 that have no customers and are no longer available are also being removed. Tariff language associated with Special Facilities Routing of Access Service is being deleted for the same reason. Qwest is making these changes as part of an effort to clean up existing tariff language to reduce customer confusion and make it easier for potential customers to find information in the tariff.

Supporting information discussed under Sections 61.38 and 61.49 of the Commission's Rules is, to the extent required, included in this transmittal letter and the attached documentation.
