Under authority of Special Permission No. 08-023 of the Federal Communications Commission, Verizon is submitting tariff pages to introduce a new contract tariff option in its Tariff FCC No. 1. The contract tariff option provides billing discounts on certain Special Access Services to commercial mobile radio service providers who meet the eligibility requirements and maintain volume commitments and total billed revenue amounts for High Capacity 1.544 Mbps (DS1) and High Capacity 44.736 Mbps (DS3) Services. This new Contract Option is being filed in Tariff FCC No. 1 where Verizon has received Pricing Flexibility relief for Special Access Services in Qualifying Metropolitan Statistical Areas.

Supporting material as specified under Section 61.49 of the Commission's Rules is not required with this filing. However, a document with a detailed explanation of the filing is being provided as an attachment hereto.
