The enclosed tariff, issued by the Verizon Telephone Companies (Verizon) and bearing Tariff FCC No. 1, Access Service, is being sent to you for filing in compliance with the requirements of the Communications Act of 1934, as amended. With this filing, Verizon is filing revisions to make certain corrections. On May 31, 2007, under Transmittal No. 813, Verizon filed tariff revisions introducing Verizon Integrated Optical Service Tariffed Service Components for DS1 and DS3 Riders in its Tariff FCC Nos. 1, 11, 14 and 16. These rates were introduced with a rate zone structure in FCC Nos. 1 and 14. DS1 Riders were introduced with a rate of \$75.00 per appearance. DS3 Riders were introduced with a rate of \$150.00 per appearance.

On July 30, 2007, Verizon filed tariff revisions under Transmittal No. 833 to modify Tariff FCC Nos. 1 and 14 to collapse the rate zone structure into a non-zoned structure. Then, on August 3, 2007, Verizon filed tariff revisions under Transmittal No. 838 to introduce pricing flexibility rate elements. The pricing flexibility rates were the same as the N-MSA rates. As part of Transmittal No. 838, the material filed under Transmittal No. 833 had to be reissued because it had not yet been in effect for thirty (30) days. When the material was reissued in Tariff FCC No. 1 for DS3 Riders, it was inadvertently reissued with the DS1 Rider rates. Therefore, both the N-MSA and the matching pricing flexibility rates were erroneously filed at the DS1 Rider level. With this filing, Verizon is correcting the DS3 Rider rates to reflect what was originally filed under Transmittal No. 813. This also corresponds with the DS3 Rider rates issued in Tariff FCC Nos. 11, 14 and 16.

There are no customers purchasing Integrated Optical Service Riders under Tariff FCC No. 1, so there is no rate impact to customers as a result of this correction.

Supporting material as specified under Section 61.46 of the Commission's Rules is not required with this filing.

This transmittal letter and associated attachments are being filed electronically today via the Federal Communications Commission's Electronic Tariff Filing System (ETFS).
