(5) Rate Regulations

- a) A Channel Termination charge applies for each termination of SCVS. Included in the Channel Termination rate element is the use of up to twenty-five (25) feet of coaxial cable from the point at which the video service enters the customer's building to the channel interface. In the event that the customer requests that the Company extend the location of the channel interface beyond 25 feet, and the Company agrees to extend the communications path, the charges set forth for Other Labor as specified in Section 13.2.5 following will apply for the extended portion of the communications path. The extended communications path is subject to distance limitations, which are specific to the communications path being extended.

Serial Component Video Service may be connected to a Telephone Company provided integrated optical service, where such connections are technically and operationally feasible, as determined by the Telephone Company. A Serial Component Video Service Channel Termination charge will not apply at the integrated optical service end of the circuit.
