The accompanying tariff material, issued by Citizens Telecommunications Companies ("Citizens"), is sent to you for filing in compliance with the Communications Act of 1934, as amended, and with relevant orders. See, *Order*, July 2009 Annual Access Charge Tariff Filings, released March 26, 2009, DA 09-683 ("2009 Filing Order"); and *Tariff Review Plans*, Material to be Filed in Support of 2009 Annual Tariff Filings, released March 26, 2009, DA 09-684 ("2009 TRP Order").

The 2009 TRP Order, at ¶20, directs ILECs "to provide a list of services not in price caps and the tariff section associated with that service. . . . ILECs should clearly state in their cover letters where this information can be found in their TRP."
