The accompanying tariff material issued on behalf of the ACS Companies, bearing FCC No. 1 is sent to you for filing in compliance with the requirements of the Communications Act of 1934, as amended.

This filing, to become effective July 1, 2009, replaces the ACS of Anchorage Tariff FCC No. 1.

This filing proposes annual interstate access rate revisions for issuing carriers contained in the ACS Companies FCC Tariff No. 1 in accordance with the FCC's Part 69 rules and the Commission's July 2009 Annual Access Charge Tariff Filing requirements identified in DA 09-683. In addition this filing proposes to change the Federal Universal Service Contribution factor for ACS Companies Tariff FCC No. 1, which increased based on a recent FCC order¹.

This filing adds three (3) additional carriers to the ACS Companies Tariff FCC No. 1 effective July 1, 2009. These three Carriers are ACS of Alaska, Inc., ACS of Fairbanks, Inc., and ACS of the Northland, Inc. With this filing, ACS of Alaska, Inc., ACS of Fairbanks, Inc., and ACS of the Northland, Inc. will exit the National Exchange Carrier Association's (NECA) pool and be removed from the NECA FCC No. 5 Access Tariff.

In addition, this filing converts the companies listed in ACS Companies Tariff FCC No. 1 as of July 1, 2009 from Rate of Return regulation to Price Cap regulation in accordance with the ACS Price Cap Order².
