The Verizon Telephone Companies (Verizon) hereby apply for Special Permission for a waiver of Section 61.58 and 61.59 of the Commission's rules.

Following discussions with the Commission Staff, Verizon is withdrawing certain Switched Access rate revisions originally filed under Transmittal No. 1021 prior to them becoming effective on July 1, 2009, and reinstating the rates that are presently in effect. Transmittal No. 1021 was filed on June 16, 2009, to issue tariff pages and support data for the 2009 Annual Access Filing in Verizon's Access Service Tariffs FCC No. 1 (FCC 1), FCC No. 11 (FCC 11), FCC No. 16 (FCC 16), and Verizon's Facilities for Interstate Access Tariff FCC No. 14 (FCC 14).

Verizon wishes to withdraw certain rate changes proposed under Transmittal No. 1021 and reinstate material presently in effect. As a result, Verizon requests special permission to waive the requirements of Sections 61.58 and 61.59 of the Commission's rules in order to withdraw certain material pending under Transmittal No. 1021 prior to its scheduled effective date of July 1, 2009.

This application and associated attachments are being filed electronically today via the Federal Communications Commission's Electronic Tariff Filing System (ETFS).
