AT&T also hereby withdraws the portions of its Petition To Suspend And Investigate the July 1, 2009 tariff filings of Northwest Iowa Telephone Company, Geneseo Communications Inc., and Union Telephone Company ("Union") that pertain to Union, because Union has corrected the errors in its July 1, 2009 tariff filing on which AT&T's Petition To Suspend And
