This filing is being made by Qwest is its Tariff F.C.C. No. 1, Section 13, Miscellaneous Services, to introduce a new service, Local Calling Area Data Tables (LCADT) Subscription. LCADT is a new Basic Service Element that provides tables used to identify Qwest's local calling areas as provisioned in the Company's local switches. The current new services test supersedes the old one in FCC Report and Order on Further Reconsideration & Supplemental Notice of Proposed Rulemaking ("R&O"), FCC 91-186, CC Docket No. 89-79, CC Docket No. 87-313, *In the Matter of Amendments of Part 69 of the Commission's Rules Relating to the Creation of Access Charge Subelements for Open Network Architecture Policy and Rules Concerning Rates for Dominant Carriers* 6 FCC RCD 4524 (1991).
