In the event that video electronic equipment is unavailable and the Telephone Company must secure and ship electronic equipment in order to satisfy a customer's request for part-time Broadcast Video or Advanced Broadcast Video Service*, the customer shall be given the option to authorize the Telephone Company to secure and ship the equipment or to cancel the order. If authority is given to the Telephone Company to obtain the equipment, the customer shall be advised of all shipping and related charges (USOC NREVE will identify the amount of shipping and related charges.) Such charges shall be flowed through to, and be the responsibility of, the customer. If the customer is unwilling to authorize payment of shipping and related charges and elects to cancel the order for service, cancellation charges as set forth in Section 5.2.3 preceding will not apply.

In addition, a Non-Standard Premises Connection Charge will apply, per customer, per NSP, for the installation of the first Telephone Company-provided 1.544 Mbps High Capacity, 44.736 Mbps High Capacity and DIGIROUTESM digital service II Special Access Service at a Non-Standard Premises (NSP) except when Special Construction has already been assessed to such premises for the provision of Special Access Service to that Non-Standard Premises. Any additional Special Access Services ordered to the same NSP by the same customer will not be subject to the NSP Connection Charge.
